## **Farmers and Merchants Bank Junior Board of Directors**

- Students from the Putnam County School System and Gatewood Schools are chosen annually in the spring of each year. (You must be an upcoming Senior in the Fall)
- Term begins in May and last throughout the school year. Attendance at one summer activity will be required (typically the Torture Trail Road Races, which take place the first Saturday in June).

### **Duties**

- Attend monthly meetings (*we ask that you do not miss more than TWO meetings*)
- Provide guidance on how Farmers and Merchants Bank can better serve the young adult market.
- Take an active part in bank and/or community projects
- Represent Farmers and Merchants Bank as a delegate to the community.

## **Junior Board of Directors**

- All applications are due on April 15th.
- Applicants must fill out the application and present TWO letters of recommendation.
- Applicants must write an essay on one of the following topics: (200 – 250 words)
  - **What a Community Bank means to the local community.**
  - **What does Leadership mean to you?**
- **TWO** Letters of recommendation: one should be from a **local business leader** and one from a **teacher** based on academic achievements and/or leadership abilities.
- The Junior Board will consist of Seniors.

- The Junior Board position runs from May to May of the next year.
- The Junior Board goes on one field trip a year to the Chick-Fil-A Headquarters in Atlanta Georgia.
- The Junior Boards will meet on at least one Saturday for a Ropes Course Challenge at Rock Eagle 4-H Center. There may also be other Saturday volunteer events the board members are asked to attend (attendance for these won't be mandatory but highly encouraged. Ex. Torture Trail Races, Shred day, etc).
- The Junior Board members will have a party in May to say goodbye to the old board members and hello the new.

### **Disciplinary Action**

- Any action that does not represent the bank or yourself in a respectable manner will be grounds for dismissal. It will be at the banks sole discretion to determine when a dismissal is appropriate.
- ***Two unexcused absences from the monthly meetings will result in dismissal from the board.*** We know and understand that there will be scheduling conflicts with other group activities you are a member of however we also expect the same level of commitment you make to these to be made to the Jr. Board Program. Please be mindful of this when applying and take your attendance seriously.

## **Criteria for Scholarship Consideration**

A scholarship may be awarded to a Junior Board Member from Putnam County High School, Gatewood School and/or Lake Oconee Academy. They must display extraordinary understanding of community banking, be active in community activities, attend the meetings and conduct themselves appropriately considering the position of Junior Board Member of FMB.

At the end of each school year, the seniors on the Junior Board can apply for a scholarship presented by Farmers and Merchants Bank. The following is the criteria for scholarship consideration:

- Typed essay, length and subject to be announced at the April Board Meeting.
- Junior Board participation with meetings, projects and/or events and contributions
- Meeting Attendance
- Grade Point Average (GPA)
- Three letters of recommendation from a teacher, business leader and recognized community leader. (i.e. Pastor)

All of the above criteria will be considered in determining the Scholar to be awarded this year's scholarship. You don't have to meet all the above criteria. A combination of the criteria will determine the best candidate.
