### **Farmers & Merchants Bank Junior Board of Directors**

- Students from Putnam and surrounding counties are selected annually in the spring. (Applicants must be rising seniors in the fall.)
- The term begins in May and continues throughout the school year. Participation in at least one volunteer opportunity with the Junior Board is required.
- The Junior Board participates in various community events.
- Saturday volunteer events may also be organized. While attendance is not mandatory, it is highly encouraged (e.g., Shred Day at FMB, LOABA's The Big Event, etc.).
- A cookout will be held in May to bid farewell to the outgoing board members and welcome the new members.

#### **Duties:**

- Attend monthly meetings (We ask that you do not miss more than TWO meetings).
- Offer guidance on how Farmers & Merchants Bank can better serve the young adult market.
- Actively participate in bank and community projects.
- Represent Farmers & Merchants Bank as a delegate within the community.

#### **Benefits to the Participant:**

- Educational opportunities for community involvement.

- Access to a checking account (required for monthly meeting payment deposits at Farmers & Merchants Bank).

### Junior Board of Directors

- All applications are due by **April 10, 2026**.
- Applicants must complete the application form and submit TWO letters of recommendation.
- Applicants must write an essay (200–250 words) on one of the following topics:
  - **What does a community bank mean to the local community?**
  - **What does leadership mean to you?**
- **Letters of Recommendation:** One letter should be from a local business leader, and the other should be from a teacher, focusing on academic achievements and/or leadership abilities.
- The application process consists of two steps: the Written Portion and the Interview Portion. **If selected based on the written application, you will be invited for an interview. Interviews will take place the week of April 20<sup>th</sup>-24<sup>th</sup>.** Those advancing to the interview stage will be contacted with the interview date and time.

#### Disciplinary Action

- Any behavior that does not reflect the bank's values or fails to represent yourself in a respectful manner will be grounds for dismissal. The bank reserves the sole discretion to determine when dismissal is appropriate.
- More than two unexcused absences from monthly meetings will result in dismissal from the board. We understand that conflicts with other activities may arise, but we expect the same level of commitment to the Junior Board Program as you give to your other commitments. Please consider your attendance carefully when applying.

- Junior Board members are expected to wear their bank shirts and khakis to all meetings and projects (Bank shirts will be provided.)
